TRCA PAYMENT OPTIONS

QUARTERLY ASSESSMENTS: Due on the 1st of January, April, July, and October. Payments received after the 15th of the month they are due will be charged a late fee of \$15.

Please note the following payment options:

ONLINE PAYMENT OPTIONS: Go to www.tatumranch.org and click on the link at the top of the page, **Homeowner Portal > First Citizen's Bank Portal**. The Management ID is 7948, the Association ID is 2485. Use your nine-digit **Account Number** for your Property/Account Number. Your Account Number is shown on your assessment statement payment coupon. (NOTE: Once you set up your First Citizen's portal account, your username is your email address).

**Tatum Greens Residence: Please contact our office before setting up online payments through our portal.*

1. E-Check (ACH) – You may set up a one-time or recurring payment from your bank account. There are no additional fees for this payment option. E-Check payments may take up to 24 hours to process.
2. Credit Card – All credit cards are accepted. First Citizens Bank charges a 2.95% service fee for credit card transactions. Credit card payments are processed instantly.

BILL PAY SERVICES THROUGH 'YOUR' ACCOUNT:

1. Ensure the *Bill Pay* check is made payable to "TRCA" and include **your nine-digit Assn ID -Account Number, i.e. (2485#####)** in the memo line. Your Account Number is shown on your assessment statement payment coupon. Your banking institution may charge a fee using Bill Pay Services. Mail to address below, noted under U. S. Postal Service Payments. Bill Pay payments may take up to 2 weeks to be mailed, received, and processed from your banking institution.

2. If you are paying for multiple properties, you may use one envelope, but please include separate checks with the appropriate Property Account Number noted on each check.
3. Payments are posted by the date they are received. We do not accept postdated checks.
